3. Registration ONLINE will close at 8:00 pm on Friday, November 3, 2017.
4. Registration ON SITE will be available between 6:00 am and 8:00 am on Saturday, November 4.
5. All Anglers weighing in must present their current fishing license, a valid form of photo ID and their tournament registration number which will be sent to registrants upon completing the registration process. Per the Tennessee Wildlife Resource Agency, children under the age of 13 are not required to have a fishing license.

## Waiver of Liability & Hold Harmless Agreement

1. **Liability Release:** On behalf of myself and my heirs, successors, servants, assigns, executors, administrators, guardians, and conservators, I HEREBY RELEASE, DISCHARGE, CANCEL, WAIVE, COVENANT NOT TO SUE, ACQUIT, AND HOLD HARMLESS the T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston, Roland Martin, Team Nashville BassMasters and its tournament directors, partners, employees, consultants, principals, agents, servants, heirs, administrators, shareholders, successors, directors, officers, representatives, attorneys, and assigns as well as any governmental entity where the event is held, and agree to hold them free and harmless for, from, and against any and all claims, judgments, appeals, rights, demands, costs, expenses, liabilities, obligations, actions, and causes of actions of any character or form whatsoever, whether known or unknown, suspected or unsuspected, arising from their negligence or otherwise, including, but not limited to, all liabilities for personal injury, property damage, or wrongful death caused by such negligence or otherwise resulting from participation in the event listed above (the "Claims").
2. **Rules & Membership:** I have read, understand, acknowledge, and agree to abide by all rules set forth by the T.J. Martell Foundation and Team Nashville BassMasters for Th3 Legend's "Cast for a Cure" Big Bass Tournament. I understand that should I be found in violation of any tournament rule, it may result in a penalty, event disqualification, and forfeiture of any prizes earned at the event in which I participated. I agree to fully comply with all laws, ordinances, rules, regulations and orders of all applicable and appropriate local, state and federal entities having jurisdiction over any aspect of the Event.
3. **Indemnification:** I also agree to indemnify and defend the T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston, Roland Martin, and Team Nashville BassMasters against the claims, and other damages, costs and expenses, including reasonable attorney's fees, resulting from any claim made by me or my agents or successors-in-interest. I understand and agree that under this provision, T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston,

Roland Martin, and Team Nashville BassMasters will be indemnified by me whether T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston, Roland Martin, and/or Team Nashville BassMasters potential liability for claims has risen as a result of T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston, Roland Martin, and Team Nashville BassMasters negligence alone or of co-negligence with me, or the negligence of others, with respect to all claims.

4. **Assumption of Risk:** I acknowledge that this Event involves certain risks and hazards, including the risk of accidental injury or death, or loss or damage to property, resulting from wild animals, inclement weather, accidents, equipment malfunctions, collisions, falls, drowning, equipment and gear, related injuries or other causes known or unknown to the T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston, Roland Martin, and Team Nashville BassMasters. I also acknowledge that I carry the minimum levels of state mandated liability insurance for any vessel or vehicle that I may operate as a participant in this event, and I have obtained any and all permits or licenses necessary for participating in the Event.
5. **Good Health & Expertise:** I attest and verify that I am physically fit, am enjoying good health, and have sufficient expertise and stamina for participation in this Event. I understand that fishing and hunting are physically strenuous activities and that I will be exerting myself during this Event, and that if injured as a result of heart attack, panic, hyperventilation, or any other physical malady, etc, that I expressly assume the risk of said injury. I understand that in case of emergency, I hereby authorize any licensed medical personnel to perform any accepted medical assistance deemed necessary and I agree to bear the expense of any such treatment.
6. **Promotion:** I also irrevocably authorize the T.J. Martell Foundation, Th3 Legends Inc., Bill Dance, Jimmy Houston, Roland Martin, and Team Nashville BassMasters and any assignee to use my name, voice, likeness, biographical information and/or tips in photography, audio, video, or any other format for publication, advertising, promotional or any other purposes, without restriction as to changes or alterations from time to time. I understand that I will not be entitled to receive any royalties or other compensation in connection with such use and expressly waive any claim of ownership in and to any and all copyrights related thereto. Further, I specifically waive any claims for right of publicity or right to privacy for any recording, photograph, or film in which I appear which is directly or indirectly related to the Event.
7. **Minors:** In the event a Minor wins any prize monies from the Event, prior to the disbursement or transfer of any and all prize monies to the Minor, the Minor shall: (i) create a custodial account with a Financial Institution and designate a Custodian pursuant to the Tennessee Uniform Transfer to Minors Act ("Act"); (ii) present proof of such custodial account with the Financial Institution to the T.J. Martell Foundation; and (iii) acknowledge and agree that any and all payment(s) shall be made directly to the custodial account at the Financial Institution up until the individual is no longer a Minor, at which time such Minor may designate in writing to T.J. Martell Foundation where to direct such monies. Any term not defined under this Section 7 shall have the definition given to it in the Act.
